This meeting was followed by the Annual Planning Meeting where initially Penny Spiller spoke of the way forward for Twinning and we talked through the Strengths, Weaknesses, Opportunities and Threats and how changes/improvements could be made. It was proposed that a representation be made to the Full Yate Town Council meeting on January 10th to raise their awareness of our commitment and request their support.

MM told the meeting that some members had met up with some of our friends from Germany recently when they were staying at the Hilton Hotel at Bradley Stoke on a visit to England (unrelated to Twinning). During this meeting we were informed it is very unlikely there would be a twinning trip to England for 2017, if so this will be the first time in 32 years there hasn't been an exchange visit.
