## **Minutes of the Annual General Meeting held on Friday October 12<sup>th</sup> 2012 at 7.30pm in Poole Court**

### **5. Reports by 2011/12 Officers:**

**Treasurer:** the audited accounts of the Association were made available, IB explained that there had been a change of auditor: C. IB gave notice of a change needed for the 2013 AGM: we will not be able to use the word “auditor” unless that person is properly qualified as an auditor. IB then proposed that the accounts for 2012 be adopted. This was seconded by MP and carried unanimously.

**Chairman:** RB highlighted the visit from Germany in March and the very enjoyable coach trip to Germany in August. In June there had been the Presentation at Brimsham Green School: this year the Twinning Association Award for International Understanding was presented to the Sixth Form Group who were visiting a school in Uganda. RB then asked PP to report on the Association website: members are asked to look carefully at the website and make suggestions for input.
